

CAMP ROBIN HOOD LTD.

2023 Conditions of Registration

I/we agree to allow my/our child(ren) to participate in all camp activities and in any supervised trips to places not on the camp property (e.g. Zoo, Movie Theatres, Other Camps, etc.).

I/we hereby apply for registration for the herein named child(ren) for the camping and transportation services indicated in this application and any subsequent forms to be completed.

In consideration of acceptance of this application by Camp Robin Hood Ltd. I/we hereby agree as follows:

- a. That the Directors of Camp Robin Hood Ltd. reserve the right to terminate the registration of any campers when it is deemed by the Directors to be in the best interest of the child or the camp. In such an event, it is at the discretion of the Directors of Camp Robin Hood Ltd. whether to provide a proportionate refund.
- b. To make all payments (VISA, MASTER CARD, Cheque or E-Transfer) required in accordance with the fee schedule in effect on the date of registration, to abide by the conditions of registration in the registration package. (2% Interest per month charge on unpaid balance after May 1st.)
- c. The first day of camp is Monday, July 3rd, 2023. There will be no camp on the Civic Holiday Monday, August 7, 2023.
- d. Applications cannot be confirmed unless accompanied by the required deposit or full payment of camp fees per child. Your child(ren) will only be permitted to start camp once fees are paid in full prior to the start of their camp session.
- e. Your deposit is refundable, if we cannot confirm your application.
- f. Your deposit is fully refundable if a camper's reservation is cancelled in writing before February 1, 2023.
- g. Our fees are for services for a specific period and not a day-to-day fee. There are no refunds for days missed for any reason.
- h. To consent to the use by Camp Robin Hood Ltd. of the camper's likeness for publicity purposes, including website and social media channels.
- i. In case of illness of 2 consecutive weeks or more, a refund of up to 50% will be considered by the Camp Directors. A written request accompanied by a doctor certificate is required for consideration.
- j. Once a session has begun, changes between Camp Robin Hood and Robin Hood Sports Academy and vice versa, will be subject to a \$25.00 administrative fee.
- k. Cancellation or reduction after February 1, 2023 are subject to the following fees:
 - o Cancel in February or March 2023, \$250.00 Administrative Fee per camper
 - o Cancel in April or May 2023, \$500.00 (deposit) Administrative Fee per camper
 - o Cancel in June 2023, 50% of camp fee
 - o Cancel in July or August 2023: No Refund
 - o Reduce Session in February or March 2023: \$100.00/session per child
 - o Reduce Session in April or May 2023: \$150.00/session per child
 - o Reduce Session in June 2023: No refund, however, a credit will be given for the following camp season less an administration charge of \$200.00.
 - o Reduce Session in July/August 2023: No refund, however, a credit will be given for the following camp season less an administration charge of \$250.00
- l. To give camp officials authority to act on my behalf in case of emergency.
- m. To release and indemnify Camp Robin Hood Ltd. from any and all claims for losses or articles and damages arising as a result of any accident, injury or otherwise sustained by the herein named child(ren) arising from participation in any camp activities.
- n. Camp Robin Hood is not responsible for the loss or damage to Campers' belongings and/or equipment and/or other items while in transit or at Camp Robin Hood.

o. COVID-19

Camp Robin Hood reserves the right to change or update our policies and/or programs as it relates to the COVID-19 pandemic.

- Applicant acknowledges that COVID-19 continues to spread throughout Canada and that it is possible that the Applicant and members of their family may come in contact with other adults and children, and that it is possible that the applicant and members of their family could become sick with or exposed to COVID-19, whether at camp or elsewhere. The Camp will maintain proper (and enhanced) hygiene and infection control practices at camp, but cannot guarantee that participants will not become infected with or be exposed to COVID-19. Additional Waivers may be required closer to the summer.
- COVID-19 related full refunds will ONLY be available if the Government does not allow day camps to operate before or during the season due to COVID-19.
- Dependant on Ministry of Health guidelines, the ability to switch cabins or switch programs once a session has started may be limited or unavailable.
- The Parent and/or Legal Guardian understands that they may need to fill out a daily screening form for each child attending camp, attesting to the child's good health and that they are not exhibiting any symptoms of COVID-19 and have not been in contact with any persons that have tested positive for COVID-19.
- The Parent and/or Legal Guardian agrees to keep their child(ren) home and notify the camp in writing, if they are sick, not feeling well for any reason, and/or exhibiting any symptoms of COVID-19. The child's return to camp will be determined in conjunction with advice and consultation from local Public Health.
- Camp Robin Hood does not require all camp participants to be fully vaccinated against COVID-19. Should this become a requirement, parents wishing to withdraw may request (in writing) a full-refund. In the event of a COVID illness at camp, campers with different vaccination statuses may be managed differently (i.e., unvaccinated ill campers might be required to have a longer return to camp period whereas equivalent vaccinated campers might not).

COVID- 19 "In-Summer" absence policy:

Once camp begins, no refund or credits will be given for any incidental absences or missed days. However, in the event that a camper is required to stay home from camp due to COVID-19 public health directives, the following policy will be applied:

First 4 days of Absence: Camp fees and bus transportation: Non refundable.

Additional days absent (5 or more):

1. Choose credit of 100% of prorated daily fee or refund 50% of prorated daily fee.
2. Transportation Refund (if applicable) for 5th and more days - \$20.00/day for door-to-door transportation and \$10.00/day for neighbourhood.

- p. The Parent and/or Legal Guardian hereby understands that Camp Robin Hood will have zero tolerance for physical and/or verbal abuse towards any staff by Parents. Please respect the staff that look after the care of your children while at camp. Any person found in breach of this condition may be asked to terminate their child's time at Camp. In the case of camper termination, a refund for the remaining days would be issued.
- q. The Parent and/or Legal Guardian hereby consents to the sharing of your personal information with Camp Walden.
- r. This document in conjunction with our COVID-19 policies sets forth the entire agreement between Camp Robin Hood, the Parent and the Camper and supersedes and replaces all other discussions, agreements, (whether written or verbal), contracts, representations, promises, negotiations or any other matter. This document can only be changed, modified or amended in writing by both parties.
- s. That the Courts of the Province of Ontario shall have exclusive and preferential jurisdiction to entertain any complaint, demand, claim, proceeding, or cause of action whatsoever arising from my experiences with Camp Robin Hood. I hereby agree that if I commence any such legal proceedings, that I will do so only in the Province of Ontario.
